We the undersigned subscribers of thoses articles of incorporation each neutral person competent to contract, do hereby associate ourselves together to form a corporation for profit under the law of the State of Florida.

ARTICLE I

The name of the corporation is SouthEast Seafood Distributors, Inc.

ARTICLE IX






