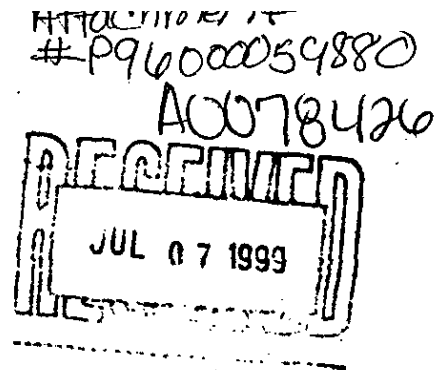
I ask you show mercy at these circumstances and waive the late fee.
