**ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this Corporation is JR. TIRE & ACCESSORIES, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing
on July 12, 1996.
