

# ARTICLES OF INCORPORATION

OF

OLIVIA S. BENSON, ESQ. P.A.

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a professional association pursuant to Chapter 621 of the Florida Statutes.

## ARTICLE I - NAME

The name of the corporation shall be Olivia S. Benson, Esq. P.A.

# ARTICLE III - COMMENCEMENT & DURATION

## **ARTICLE Y - STATED CAPITAL**

#### ARTICLE VII - INCORPORATOR

### ARTICLE VIII - BOARD OF DIRECTORS

The corporation shall have one director initially. The number of directors may be increased from time to time thereafter in accordance with the bylaws of the corporation but shall never be less than one. #### ARTICLE IX - SHAREHOLDER PROPERTY

Private property of the shareholders shall not be subject to the payment of the corporation's debts. The corporation shall have a first lien on the shares of its shareholders and upon the dividends due them for any indebtedness of the shareholders to the corporation.

#### **ARTICLE X - AMENDMENTS TO ARTICLES**
