ARTICURE OF INCORPORATION OF WESTAR DIVIS HIGHWAY. INC.

ARTICLE I. NAME

The name of the corporation is WESTAR DIXIE HIGHWAY, INC.

ARTICLE II. DURATION AND COMMENCEMENT OF EXISTENCE

The corporation is to have perpetual existence, commencing at the filing of these articles with the Department of State.
