Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of Hire Right, Inc. (the "Corporation") are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is Hire Right, Inc.

SECOND: Article I of the Articles of Incorporation is amended in its entirety to read as follows:

"ARTICLE I

Name

Section 1.1. Name. The name of the corporation is Unlimited EQ, Inc."
