ARTICLES OF INCORPORATION

In compliance with the requirements of Florida Statutes Chapter 607, the undersigned, being a natural person, does hereby act as Incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I - NAME AND ADDRESS OF CORPORATION

The name of this corporation is J. HOPE EVENTS UNLIMITED, INC..
The street address of the initial principle office of this corporation is 8301 N.W. 98th Avenue, Tamarac, Florida 33321.

ARTICLE II - PURPOSE OF CORPORATION

The general purposes for which the corporation is organized are:

- 1) Planning, programming and staffing of special events and
- 2) To transact any other business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE III - CAPITAL STOCK

The maximum number of shares this corporation is authorized to issue is one hundred (100), all of which shall be common shares. Such shares shall have a par value of \$1.00.
