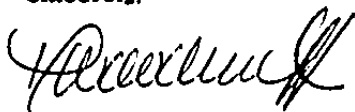

The general purpose of this corporation shall be the transaction of any and all lawful business. This corporation shall have all of the powers enumerated in the Florida General Corporation Act, as the same now exists and as hereafter amended, and all such other powers as are permitted by applicable law, including, without limitation and only by illustration, the following:

(a) To have a corporate seal, which may be altered at pleasure, and to use the same by causing it, or a facsimile thereof, to be impressed, affixed, or in any other manner reproduced.

(b) To purchase, take, receive, lease, or otherwise acquire, own, hold prove, use and otherwise deal in and with real or personal property or any interest therein, wherever situated.

(c) To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer, and otherwise dispose of all or any part of its property and assets.

(d) To lend money to, and use its credit to assist, its officers and employees.

Article VII: Commencement of Corporate Existence

This corporation shall commence corporate existence immediately upon the filing of these Articles with the Secretary of State and shall have perpetual existence unless sooner dissolved according to law.

Article VIII: Limited Liability of the Shareholders

The private property of the shareholders shall not be subject to payment of the Corporation's debts to any extent.
