ARTICLE I NAME, REGISTERED ADDRESS & AGENT, INC.

THE NAME OF THIS CORPORATION SHALL BE NEW HOPE TRUST, AND SAID CORPORATION SHALL BE LOCATED IN PINELLAS COUNTY, FLORIDA, WITH ITS REGISTERED ADDRESS AT 2286 WILLOWBROOK DR. CLEARWATER, FL. 346 24, OR AT SUCH OTHER PLACE AS THE DIRECTORS MAY FROM TIME TO TIME DESIGNATE, AND THE NAME OF THE REGISTERED AGENT OF THIS CORPORATION AT THAT ADDRESS IS LYNN KESSELMAN. THE MAILING ADDRESS SHALL BE THE SAME AS THE REGISTERED AGENT'S ADDRESS.
