**ARTICLES OF INCORPORATION**

The Undersigned, acting as Incorporator of a corporation not for profit pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation of such corporation.

**ARTICLES**

The name of this corporation shall be **LAKE WORTH & LANTANA SEVENTH DAY ADVENTIST CHURCH, INC.** The mailing address of this corporation shall be:

**ARTICLE II**

The existence of this corporation shall be perpetual.

**ARTICLE III**

The purposes of the Lake Worth & Lantana Seventh Day Adventist Church, Inc. are:

- 1) To provide a place for christian worship and fellowship for all its members.
- 2) To give primacy to the spiritual rather than to the material values of life.
- 3) To encourage christian daily living of all members and their families.
- 4) To develop, by precept and example, a more intelligent, aggressive, and serviceable christian citizenship.
- 5) To provide through this Assembly, a practical means to form enduring friendships, to render altruistic service, and to build better christian communities,
- 6) To cooperate in creating and maintaining that sound public opinion and high idealism which make possible the increase of righteousness, justice, and christian ministry.
- 7) To do all such things as are incidental or conducive to the attainment of the above objects.

#### ARTICLE VIII

These Articles may be amended by a two-thirds vote of the membership of the corporation at a duly noticed meeting.




