Articles of Incorporation  
of

Professional List, Inc.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Professional List, Inc.

Article 2. ~~1801 24th Street, Vero Beach, Florida 32960~~  
The mailing address for Professional List, Inc. shall be Post Office Box 4539, Ft. Pierce, Florida 34948.

Article 3. The duration of the Corporation is perpetual.

Article 4. The general purposes for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
