ARTICLES OF INCORPORATION FOR GORNIK DESIGN, INC.

We, the undersigned, hereby associate together for the purpose of becoming a corporation under the laws of Florida, by and under the provisions of the Statues of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of corporations for profit.

ARTICLEJ

The name of the corporation shall be:

GORNIK DESIGN, INC.

Its business shall be carried out in Orlando, Orange County, Florida and in the United States and foreign countries as may, from time to time, be authorized by the Board of Directors. Its principal office shall be at 3115 Tall Timber Drive, Orlando, Fl 32812.

ARTICLE II:

The general nature of the business to be transacted is as follows:

Section 1: To engage in any activity permitted under the laws of the United States and the State of Florida.

Section 2: That f purchasing, leasing, renting, selling, holding and otherwise acquiring and disposing of real estate and personal property, both tangible and intangible, and chooses in action either as owner, agent or factor.

Section 3: In the purchase or acquisition or property, business rights of franchise, or for additional working capital, or for any other object in or about its business affairs, and without limit as to the amount, to incur debts, and to raise, borrow and secure the payment of money in any lawful manner, including the issue and sale or other disposition of bonds, warrants, debentures, obligations, negotiable and transferable instruments and evidences of indebtedness of all kinds, whether secured by mortgage, pledge, deed of trust, or otherwise.
