The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

7-10-96

The name of the corporation shall be: MODERN PERINATAL CARE OF BROWARD, INC.

The period of duration of the corporation is perpetual.


