ARTICLE I. NAME AND ADDRESS. The name and address of this corporation shall be , Oakland Used AutoParts, Inc., and its principal office is located at 706 Saginaw Avenue, Clewiston, Florida 33440-2310.

ARTICLE II. DURATION. This Corporation is to exist perpetually.

ARTICLE III. PURPOSE. This corporation is organized for the Purpose of the transaction of any lawful business for which corporations may be incorporated under the laws of the State of Florida.
