THE NAME OF THE CORPORATION IS LEO'S DINER AND CATERING, INC.

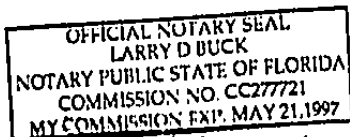

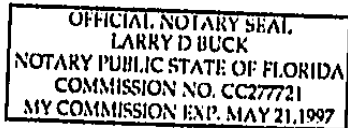
