ARTICLES OF INCORPORATION

INTERVENTIONAL REHABILITATION CORPORATION

under the Florida General Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I

NAMB

The name of this corporation is Interventional Rehabilitation Corporation. The principal place of business is 125 W. Romana Street, Suite 222, Pensacola, Florida 32501.

ARTICLE II

DURATION

The duration of this corporation is perpetual.

ARTICLE III

PURPOSE

The general purposes for which this corporation is organized are:

- (1) To transact any lawful business or businesses for which corporations may be incorporated under the Florida General Corporation Act.
- (2) To do such other things as are incidental to the foregoing or necessary, implied, helpful, or desirable in order to accomplish the foregoing.
