ARTICLES OF INCORPORATION

OF

ALL STAR HOME RENTALS, INC.

The undersigned natural person, having capacity to contract and acting as the Incorporator of this Corporation under the Florida General Corporation Act adopts the following Articles of Incorporation for such Corporation, to-wit:

ARTICLE ONE: NAME AND PRINCIPAL OFFICE

The name of the corporation is: ALL STAR HOME RENTALS, INC.

The address of its principal office is: 11408 Woodchuck Drive, Boca Raton, Florida 33428.

ARTICLE TWO: COMMENCEMENT AND DURATION


