ARTICLES OF INCORPORATION  
OF  
ALAN RICHARDS HANDYMAN, INC.

The undersigned Incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

Article 1. Name

The name of the corporation is Alan Richards Handyman, Inc.

Article 2. Nature of Business






ACCEPTANCE OF DESIGNATION BY REGISTERED AGENT
