ARTICLES OF INCORPORATION OF

The undersigned hereby organizes a corporation for profit under the provisions of the Florida Professional Service Corporation and Limited Liability Company Act (the "Act"), and pursuant to the following Articles of Incorporation.

ARTICLE 1 Name

The name of the corporation is:

ARTICLE 2 Purposes

The general nature of the business to be transacted by the corporation shall be to engage in every aspect of the practice of medicine. The professional service involved in the corporation's practice of medicine may be rendered only through its officers, agents, and employees who are duly authorized and licensed to practice medicine in the State of Florida. The stock of this corporation may be issued, owned, and registered only in the name or names of an individual or individuals who are duly authorized and licensed to practice medicine in the State of Florida, and who are employees, officers, or agents of this corporation. If a stockholder (a) becomes disqualified to practice medicine in this State; or (b) accepts employment that, pursuant to law, places restrictions or limitations upon his continued rendering of medical services; or (c) sells, transfers, hypothecates, or pledges, or attempts to sell, transfer, hypothecate, or pledge any shares of stock in this corporation to any person ineligible by law or by virtue of these Articles to be a shareholder in this corporation, or if such sale, transfer, hypothecation, or pledge is made in a manner prohibited by law, or in a manner inconsistent with the provisions of these Articles or by the Bylaws of this corporation; or (d) suffers an execution to be levied upon his stock, or such stock is subjected to sale or other process, the effect of which is to vest any legal or equitable interest in such stock in some person other than the stockholder; then the stock of such stockholder shall immediately stand forfeited and such stock shall be immediately cancelled by

this corporation and the stockholder or other person in possession of such stock shall be entitled only to receive payments for the value of such stock.
