THE UNDERSIGNED subscribers to these Articles of Incorporation, each a natural person, competent to contract, hereby associate themselves together to form a corporation for profit under the laws of the State of Florida; and further do agree to the following conditions of said corporation.

ARTICLE I: NAME

The name of this corporation is: GLOBAL R/C RESEARCH LAB., INC.

ARTICLE II: NATURE OF BUSINESS

The general nature of the Business to be transacted by this corporation is to do all things which natural persons might or could lawfully do in the premises as follows: GUIDENCE SYSTEM RESEARCH, AND ANY RELATED ACTIVITY PERMITTED UNDER THE LAWS OF THE UNITED STATES OF FLORIDA.

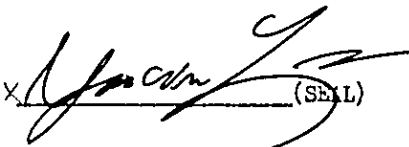
