ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article I

Corporate Name

The name of this Corporation is: Red Clay Investments, Inc.

The principal office of this Corporation is: 1440 Covey Ride
Tallahassee Florida 32312

Article II

Duration

The duration of the Corporation is perpetual.

Article III

Purpose

The general purposes for which the Corporation is organized are the following:

- a. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- b. To do such other necessary things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish such general purpose.

Article IV
