#### ARTICLES OF INCORPORATION

OF

#### GOLF COURSE DEVELOPERS, INC.

The undersigned, for the purpose of forming a corporation under the provisions of Chapter 007 of the Florida Statutes, hereinafter referred to as the Corporation, hereby agrees to the following:

## ARTICLE I Nome and Address

The name of the Corporation shall be GOLF COURSE DEVELOPERS, INC. and its mailing address is 5800-A Breekenridge Parkway, Tampa, Florida 33010.

## ARTICLE II Purpose and Powers
