The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopt the following articles of Incorporation:

ARTICLE ONE

The name of the corporation is:

The term of existence of the corporation is perpetual.

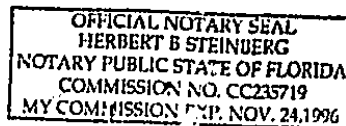
