ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

OF

DESIGNED WAREHOUSING AND DELIVERY, INC.,

Pursuant to *Florida Statutes* Section 607.1006, **DESIGNED WAREHOUSING AND DELIVERY, INC.,** a *Florida corporation*, the undersigned corporation (the "Corporation") hereby adopts the following Articles of Amendment to its Articles of Incorporation:

SECTION THREE: Article FIRST of the Articles is hereby amended, so that as so amended, said Article FIRST shall provide, in its entirety, as follows:


