Articles of Incorporation

The undersigned Incorporators hereby make, subscribe to, acknowledge and file these Articles of Incorporation for the purpose of organizing and incorporating a Corporation for profit under the Laws of the State of Florida.

Article I

The name of the Corporation shall be:

Crea-tif Hair Designs, Inc.

and it shall herein be referred to as the corporation.

Article II

The address of the principal office of Crea-tif Hair Designs, Inc. shall be 996 Westwood Square, Suite 1, Oviedo, Florida, 32765.

Article III

The general purposes for which the Corporation is initially organized is to provide the full range of Cosmetology Services, which will be: hair cutting and styling; permanent waves and permanent straighteners; coloring; highlighting and bleaching services; facial manipulation; skin care; make-up application; nail services, which will be acrylic nails, fiberglass nails, jell nails, manicures, pedicures; waxing of facial hair and other hair near bathing suit lines, under arms and back hair as is Lawfully allowed by Florida Department of Regulations.

Article IV

The aggregate number of shares which the Corporation shall have authority to issue is: 100. These shares shall consist of one class only, and such class shall be known as "Common Stock" of the Corporation. Each share shall have a Par Value of \$1.00 per share.

Article V

The street address of the initial registered office shall be: 1003 Reynolds Court, Oviedo, Florida, 32765. The name of the initial registered agent shall be Kathleen A. Pownall. To signify acceptance of appointment as registered agent, the registered agent named in the article has signed these Articles as required by law.

Article VI


