ARTICLE ONE

THE NAME OF THE CORPORATION IS IT'S ALL ABOUT FASHION INC.

ARTICLE TWO

THIS CORPORATION IS TO PROVIDE RETAIL SALES OF BOTH MALE AND FEMALE FASHIONS, AND ACCESSORIES, WHEREAS, WE WILL OPERATE THE BUSINESS AS A RETAIL MERCHANDISE FACILITY. THE VENUE WHERE THE BUSINESS WILL CONDUCT IT'S OPERATIONS WILL BE MALLS, SHOPPING CENTERS, SINGLE STRUCTURED FACILITIES AND ANY OTHER LOCATIONS AS THE BUSINESS MAY SEE FIT. 
