ARTICLES OF INCORPORATION OF OKANOGAN CORPORATION

I, Ignacio Guerrero, the undersigned, being of legal age, and natural persons, do hereby subscribe to, acknowledge, and file the following articles of incorporation for the purpose of creating a corporation under the laws of the state of Florida.

1. The name of this corporation shall be OKANOGAN Corporation.

2. The purpose of this corporation shall include the transaction of any and all lawful business for which corporations may be incorporated under chapter 607, Florida Statutes.

3. The aggregate number of shares which this corporation shall be authorized to issue is sixty (60) shares. Said shares shall consist of one class only and all such shares are \$.10 par value.

4. This corporation shall commence its existence immediately upon the filing of these articles of incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.

5. The address of the principle office of the corporation and the mailing address of the corporation shall be 1401 Brickell Avenue, Suite 500, Miami, Florida 33131. The initial registered office of this corporation shall be 1401 Brickell Avenue, Suite 500, Miami, Florida 33131, however, this corporation shall have the privilege of having its office and branch offices at other places within or without the state of Florida. 6. This corporation shall have one (1) director initially, and said director shall be Ignacio Guerrero, whose address is 8925

7. The name and address of the incorporator is Ignacio Guerrero, whose address is 8925 Collins Avenue, Apartment 11C, Surfside, Florida 33154. .

8. No contract or other transaction between this corporation and any other corporation, and no act of this corporation shall in any way be affected or invalidated by the fact that any of the directors of this corporation are pecuniarily or otherwise interested in or are directors or officers of such other corporation. Any director individually, or any firm of which any director may be a member, may be a party to, or may be pecuniarily or otherwise interested in, any contract or transaction of this corporation, provided that the fact that he or such other firm is so interested shall be disclosed or shall have been known to the board of directors or any majority thereof, and any director of this corporation who is also a director or officer of such other corporation, or who is so interested, may be counted in determining the existence of a quorum at any meeting of the board of directors of this corporation which shall authorize any such contract or transaction with like force and effect as if he was not such director or officer of such other corporation or not so interested. 16

9. This corporation shall indemnify and insure its officers and directors to the fullest extent permitted by law either now or hereafter.
