ARTICLES OF INCORPORATION

OF

RAMA, INC.

The undersigned subscribers to the Articles of Incorporation of RAMA, INC., natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I.

NAME

The name of the corporation is RAMA, INC.
