ARTICLES OF INCORPORATION CUSTOM CLASSIC HOMES, INC.

The undersigned, acting as Incorporators of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE 1

NAME:

The name of the corporation is CUSTOM CLASSIC HOMES, INC.

ARTICLE II

PRINCIPAL OFFICE/MAILING ADDRESS:

The principal office for the corporation is 600 Packard Court, Safety Harbor, Florida 34695, and mailing address for the corporation is P. O. Box 368, Safety Harbor, Florida 34695.

ARTICLE III

SHARES:

The number of shares the corporation is authorized to issue is 10,000 shares.

ARTICLE IV

PREEMPTIVE RIGHTS:

Ex h shareholder of this corporation shall have the first right to purchase shares (and securities convertible into shares) of any class, kind or series of stock in this corporation that may from time to time be issued (whether or not presently authorized), including shares from the treasury of this corporation, in the ratio that the number of shares he holds at the time of issue bears to the total number of shares outstanding, exclusive of treasury shares. This right should be deemed waived by any shareholder who does not exercise it and pay for the shares preempted within thirty (30) days of receipt of a notice in writing from the corporation, stating the prices, terms and conditions of the issue of shares, and inviting him to exercise his preemptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.
