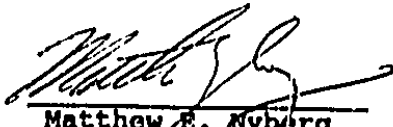
1. The name of the corporation is PRECISION WINDOW & DOOR SALES, INC.

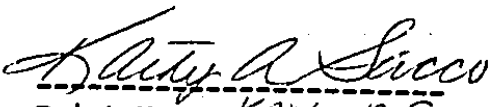

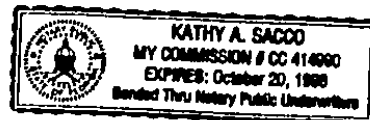
