ARTICLES OF INCORPORATION 500 JULY 100 JULY 100

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following erticles of incorporation:

ABTICLE ONE

The name of the corporation is GADGETS, INC.

AUTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The general purposes for which the corporation is organized are to engage in the retail sale and repair of telephones and electronic equipment and accessories and any other business authorized by Florida Statutes and permitted by law.

ARTICLE FOUR

The aggregate number of shares which the corporation is authorized to issue is one thousand (1,000) shares. Such shares shall be of a single class and shall have a par value of One Dollar (\$1.00) per share.

ARTICLE FIVE

The street address of the initial principal office and mailing address of the corporation is 1107 South Sixth Avenue, Wauchula, Florida 33873, and the name of its initial registered agent at such street address is HEATHER LYN LANE.

ARTICLE SIX

Pursuant to authority of Sections 607.0801 and 607.0732, Florida Statutes, or as hereafter amended, the shareholders have agreed the corporation shall have no board of directors, and all of the corporate power shall be exercised by, and the balance and affairs of the corporation shall be managed under the direction of, the stockholders. The stockholders shall have the power and authority to adopt and to amend the bylaws of the corporation and to determine consideration for the issuance or disposition of any share.
