The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

## ARTICLE I

The name of the corporation shall be: infopages.net, Inc.

#### ARTICLE II OFFICES

The principal offices of the Corporation in the State of Florida shall be located in Jacksonville, County of Duval. The Corporation may have other such offices within or without of the State of Florida as the Board of Directors or business of the Corporation may require.
