

The undersigned subscribers to these articles of incorporation, being duly licensed to practice dental medicine under the laws of the State of Florida, adopts these articles to form a corporation under the Professional Corporation Act, F.S. Chapter 621, and other laws of the State of Florida.

ARTICLE I-NAME

The name of the professional service corporation shall be Valles and Cardenas, PA.


