# ARTICLE I - NAME

The name of this corporation is Margarita & Michael Black's Touch of Elegance, Inc.

# ARTICLE II - DURATION

The duration of the corporation shall be perpetual and shall commence upon the signing and acknowledging of these Articles.

## ARTICLE III - PURPOSE
