ARTICLES OF INCORPORATION
OF
TREBOR-MIT CORPORATION

We, the undersigned, as proper persons acting as Incorporators of a corporation under the laws of the State of Florida, adopt the following articles of Incorporation:

ARTICLE I NAME

The name of this corporation shall be: Trebor-Mit Corporation d/b/a Quizno's.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III SHARES

This corporation is authorized to issue 100 (one hundred) shares of \$1.00 (one dollar) par value Common Stock which shall be designated "Common Shares".

**ARTICLE IV INITIAL REGISTERED AGENT

ARTICLE VI PURPOSE
