The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be SISTERS IN THE POT, INC..

ARTICLE II

The corporation shall have perpetual existence, unless sooner dissolved according to law.

ARTICLE III

The general nature of the business or businesses to be transacted by this corporation shall be: to operate specialized food service, preparation, manufacturing, distribution and related merchandise and develop relationships with tour and travel operators for the Bahamas, Caribbean and Florida;

To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell mortgage, lend, pledge or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of other domestic and

foreign corporations, associations, partnerships or individuals, or direct of indirect obligations of the United States or any other government, state, territory, governmental district, or municipality or of any instrumentality thereof.

To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises and income.

To lend money for it corporate purposes, invest and reinvest its funds and take hold real and personal property as security for the payment of funds so loaned or invested.

To conduct it business, carry on its operations, and have offices and exercise the powers granted to corporations under the Florida Statutes both within and without this State.
