To guarantee, endor " rchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shalls of capital stock of, or any bonds, and securities, or other evidences of indebtedness created by any other corporation, of the State of Florida or any other state or government, and while owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.

To transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the Bostu of Directors of the Corporation, be advantageously carried on in connection with or auxiliary to the foregoing business; and to do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
