

**ARTICLES OF INCORPORATION**  
of  
**GEORGE'S HEATING, AIR CONDITIONING, REFRIGERATION, INC.**

In compliance with the requirements of Florida Statutes Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing this business corporation.

**ARTICLE I**

The name of the corporation is "GEORGE'S HEATING, AIR CONDITIONING, REFRIGERATION, INC."

**ARTICLE II**

The existence of the Corporation shall be perpetual.

**ARTICLE III**

The street address of the principal office of the Corporation is 1025 Palisade Road, Pensacola, Florida 32504.

**ARTICLE IV**

The maximum number of shares this Corporation is authorized to issue is 100, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.


