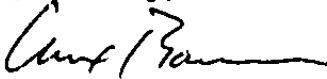

ARTICLES OF INCORPORATION

ARTICLE I - Name

The name of this corporation is Citrus Urology Center, Inc.

ARTICLE II - Duration

This corporation shall have perpetual existence.

ARTICLE III - Purpose

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - Capital Stock

This corporation is authorized to issue 1,000 shares of no par value common stock.

ARTICLE V - Initial Street Address

The street address of the initial principal office of this corporation is 3475 S. Suncoast Blvd. Homosassa Springs, FL 34448, and the name of the initial registered agent of this corporation is G. Max Barnes.

ARTICLE VI - Initial Board of Directors

This corporation shall have four (4) directors initially. The number of directors may be either increased or decreased from time to time by the by-laws, but shall never be less than one (1).

#### ARTICLE VIII - By-laws

The power to adopt, alter, amend or repeal by-laws shall be vested in the shareholders.

#### ARTICLE IX - Indemnification

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

#### ARTICLE X - Pre-emptive Rights

There shall be no pre-emptive rights.

#### ARTICLE XI - Amendment

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the

stockholders and approved at a stockholders' meeting by at least a majority of the stock entitled to vote, unless all of the directors and all of the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

ARTICLE XII - INTERNAL REVENUE CODE

This corporation is being incorporated pursuant to provisions of Section 1244 of the Internal Revenue Code and the regulations pertaining thereto.

ARTICLE XIII - Registered Agent

In accordance with Chapter 48.091, Florida Statutes, the following is submitted in compliance with said Act:

That, Citrus Urology Center, Inc., desiring to organize under the laws of the State of Florida, with its principal office at the City of Homosassa Springs, County of Citrus, and State of Florida, has named G. Max Barnes, located at 10113 Kimbrough Drive, Brooksville, FL 34601, as its agent to accept service of process within this State.
