## AMENDMENT TO ARTICLES OF INCORPORATION

OF

CITRUS UROLOGY CENTER, INC.

WHEREAS, the Articles of Incorporation of CITRUS UROLOGY CENTER, INC. were filed with and approved by the Secretary of State of the State of Florida on the 23rd day of July, 1996; and

WHEREAS, it is the intention of all of the directors and all of the stockholders of CITRUS UROLOGY CENTER, INC. that the Articles of Incorporation of CITRUS UROLOGY CENTER, INC. be amended, in accordance with the proposed amendment hereinafter set forth; and

WHEREAS, the proposed amendment was approved and adopted by all of the directors of CITRUS UROLOGY CENTER, INC., pursuant to the provisions of Florida Statutes, Section 607.0821, on the 18th day of March, 1999; and

WHEREAS, the proposed amendment was approved and adopted by all of the stockholders comprising the only voting group of stockholders of CITRUS UROLOGY CENTER, INC., pursuant to the provisions of Florida Statutes, Section 607.0704, on the  $\frac{18^{th}}{1999}$ ; and

WHEREAS, the approval of the Secretary of State of the State of Florida of the proposed amendment hereinafter set forth is hereby requested.

NOW, THEREFORE, the Articles of Incorporation of CITRUS UROLOGY CENTER, INC. are hereby amended, by deleting in its

entirety the present Article IV and by substituting therefor the following, to-wit:

## "ARTICLE IV - Capital Stock

- (a) The total number of shares of capital stock authorized to be issued by the corporation shall be 100,000 shares having a par value of \$.01 per share. Each of the said shares of stock shall entitle the holder thereof to one (1) vote at any meeting of the stockholders. The Board of Directors may authorize shares to be issued for consideration consisting of any tangible or intangible property or benefit to the corporation, including cash, promissory notes, services performed, promises to perform services evidenced by a written contract, or other securities of the corporation. Before the corporation issues shares, the Board of Directors shall determine that the consideration received or to be received for shares to be issued is adequate. All stock when issued shall be paid for and shall be nonassessable.
- (b) In the election of directors of this corporation there shall be no cumulative voting of the stock entitled to vote at such election."
