ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida General Corporation, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is:

The period of its duration is perpetual.

The purpose is to engage in any activities of business permitted under the laws of the United States and Florida, including appliance sales & service, repairs and installation.


