This is a letter to request abatement of late filing costs related to the above-stated taxpayer's Uniform Business Report (UBR). This is a comedy of errors and we would appreciate your looking deeper into the situation than literal face value.

The taxpayer filed the UBR on April 9, 2004 and attached the prescribed payment of \$150.00 with the form. Subsequently, the Division of Corporations informed the taxpayer that the form had been filed, but no check had been sent. We immediately stopped payment on the check and issued a new check which was sent on August 2, 2004. You returned that check to us inasmuch as the taxpayer failed to enter the amount of payment on the check. Please be advised that the taxpayer, Aase Eriksen is a 70-year old woman and is sole owner of Aase Eriksen Associates Limited, Inc. Please further be advised that Aase Eriksen Associates Limited, Inc. is a corporation that earns the minimalist of revenue and has not had net income in many years. We understand that we are obligated to the state in the amount of \$150.00 and are attaching a fully executed check in that amount that is being sent along with this correspondence.

To reiterate our request your forbearance by the abatement of the \$400.00 late fee:

- a) It is a comedy of errors that has caused this amount to not be paid to the state to this point.
- b) The taxpayer is 70 years old and as a result failed to execute the amount payable on the check to the state.
