ARTICLE I

NAME: The name of this corporation is TARGET AEROSPACE,
INC.

ARTICLE II

COMMENCEMENT OF EXISTENCE: This corporation shall commence
to exist on the date filed with the Secretary of State.

ARTICLE III

PURPOSE: This corporation is organized for the purpose of
transacting any and all lawful business permitted under the laws of
the United States and of the State of Florida.

ARTICLE IV

CAPITAL STOCK: This corporation is authorized to issue
500 shares of \$1.00 par value common stock, which shall be the only
class of shares.

ARTICLE V

PRE-EMPTIVE RIGHTS: Every shareholder upon the sale for
cash of any new stock of this corporation of the same kind, or
class of service as that which he already holds, shall have
the right to purchase his pro rata share thereof (as nearly as may
be done without issuance of fractional shares) at the price at
which it is offered to others.
