To Whom It May Concern,

I'm requesting you waive my corporate dissolution status and accept my \$165.00 renewal fee.

First, let me say *I am responsible* for the fact that I failed to handle the renewal of my corporation. I make no excuses nor do I blame anyone. I only ask that you understand my circumstances and extend to me whatever consideration possible toward waiving the reinstatement fee's.

Please allow me to explain. As a new corporation in 1996, I was unaware of the renewal requirement. I believed that my accountant would inform me of these type requirements, invalid assumption on my part. Also, I understand from my accountant that the corporate change of address I submitted to him was only for tax related purposes. Hence, the State of Florida was unaware of these address changes so communications of renewal requirements was impaired. As a result of a divorce process, my address has changed 3 times in the past year since my corporation was formed.

May 15th, 1997 I was divorced and while that has no bearing on my responsibilities to my corporation it represents the source of my problem - wrong address. It's my understanding that there was a renewal notice sent to my original address, 13444 SW 91st Terr., however, my ex-wife has not been very compliant with my mail, hence, I never received the renewal notice. I assure you, had I received the notice I would have sent my renewal fee on schedule. I only found out about this because when I met my ex-wife to sign a joint tax return on October 26th, she gave me the reinstatement application. This is the first mail I've received from her in a very long time and the first indication that a renewal fee was even required.

Please note, I was downsized from Ryder Corporation in June of '97, therefore, I've committed myself to making my corporation successful. I would never have knowingly failed my responsibilities to the State of Florida. I humbly ask your consideration of my situation and that you accept my check for \$165 as renewal fee for Stanley Research Institute, Inc. I apologize to the State of Florida for any inconvenience I may have caused.
