The undersigned, Joel Schenkman, as President of International Data Depository, Inc., hereby makes, acknowledges, and files the following Articles of Amendment to the Amended Articles of Incorporation. The original Articles of Organization were filed on July 25, 1996, and amended on July 29, 1996.

Pursuant to Florida Statutes, Section 607.1006, the Articles of Incorporation of the above-named Corporation are hereby amended as follows:

1. Article 3 is amended as follows: The capital stock of the corporation shall consist of five hundred (500) shares of no par value.
2. The foregoing was adopted on September 1, 2004.
3. The amendment was adopted by a unanimous vote of the shareholders at a duly noticed meeting on September 1, 2004.
