**ARTICLE I.**  
**NAME**

The name of the corporation shall be WELDON CONSTRUCTION COMPANY.

**ARTICLE II.**  
**DURATION**

The duration of the corporation shall be perpetual.

**ARTICLE III.**  
**PURPOSE**

The corporation is organized for the purpose of transacting any or all lawful business.
