
As a result of my accountant's (Mr. Edward Murray) telephone conversation with a representative from the Reinstatement Branch, I have been requested to submit an explanation as to why my company did not respond to your request to submit the 1999 Corporation Annual Report.

The reason being is that I have continually encountered problems with the post office delivering mail addressed to Atlantic Research Corporation to my post office box and some of my mail being delivered to a wrong post office box. I never am sure that all of my mail is being returned for proper delivery.

I have registered numerous complaints with the post office regarding this matter. I have also informed the postmaster of this problem and he has assured me that action has been initiated to resolve this problem. However, the problem still occurs on a regular basis. I will be moving my post office box to another post office, particularly in view of not receiving the three notices (original, second notice and dissolution letter) regarding the Corporation Annual Report.

My accountant informed me that he has knowledge of this problem existing with other clients who use the same post office I use. I have no other reason to offer for not submitting the Corporation Annual Report except that I did not receive any of the Department of State correspondence. We have no financial constraints that would have caused this omission; the company doesn't owe anyone except investors and shareholders and has a decently healthy bank balance in its account.

Please accept the enclosed corporate annual report fee submitted per the advice of the Reinstatement Branch representative and reinstate my corporation. I will be sure to closely monitor this subject in the future.
