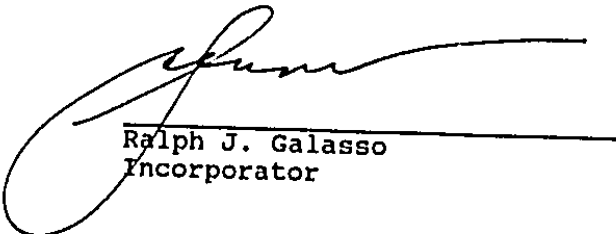
ARTICLE VII:

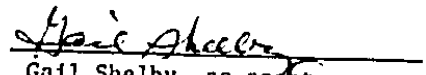
