The undersigned Subscriber hereby makes, subscribes, acknowledges, and files with the Secretary of State of the State of Florida these Articles of Incorporation, for the purpose of forming a corporation for profit, in accordance with Chapter 607, Florida Statutes, the Florida Business

ARTICLE ONE NAME OF CORPORATION

The name of this corporation is: The Snailery of Tropa, Inc.


