ARTICLE I

NAME: The name of this Corporation is LAKE HARRIS RIDGE, INC., and its address is 225 West Fifth Avenue, Mount Dora, Florida 32757.

ARTICLE II

DURATION: This Corporation shall exist perpetually.

ARTICLE III

PURPOSE: The purpose is to engage in any activities or business permitted in the laws of the United States and Florida.

ARTICLE IV

CAPITAL STOCK: The Corporation shall have the authority to issue ONE THOUSAND (1,000) shares, all of one class, FIVE DOLLAR (\$5.00) par value.

POWER TO AMEND BYLAWS: The Bylaws can only be amended by a sixty (60%) percent majority vote of the outstanding shares.

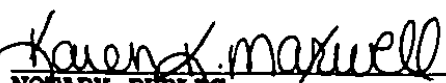
